BE IT RESOLVED, the Royal Oak City Commission hereby authorizes the mayor and city clerk to execute the construction funding agreement for Contract 24-5506 with the Michigan Department of Transportation for the federally funded 13 Mile Road Resurfacing Improvements project and directs staff to issue a purchase order in the amount of the estimated cost.

# 8.m Rezoning of 723 North Main Street to Planned Unit Development – Second Reading

Whereas the Royal Oak Planning Commission held a public hearing November 12, 2024, and recommends approval of an amendment to the Zoning Map for the purpose of rezoning 723 North Main Street (parcel no. 25-16-430-012) from "Neighborhood Business" to "Planned Unit Development" (PUD), along with approval of a final planned unit development site plan (SP 24-11-13) to construct a multiple-family building with four stories and 24 dwellings at 723 North Main Street (parcel no. 25-16-430-012); and

Whereas the Royal Oak City Commission has determined that the planned unit development will result in a recognizable and material benefit to the residents of the project and to the community, where such benefit would otherwise be unfeasible or unlikely to be achieved without application of the planned unit development regulations; and

Whereas the City Commission has determined that the proposed multiplefamily dwellings will not result in an unreasonable increase in the need for or burden upon public services, facilities, streets, and utilities; and

Whereas the City Commission has determined that the proposed development will be consistent with the public health, safety, and welfare of the city, and will not result in an unreasonable negative economic impact upon surrounding properties; and

Whereas the City Commission has determined that the proposed development is under single ownership and/or control such that there is a single entity having responsibility for completing the project in conformity with the Zoning Ordinance; and

Whereas the City Commission has determined that the Zoning Map amendment to "Planned Unit Development" and associated final planned unit development site plan are consistent with the goals and objectives of the Master Plan and received the record of public comments taken at the public hearing held at the Planning Commission meeting of November 12, 2024.

Therefore, be it resolved, that Ordinance 2024-16, entitled an ordinance to amend the Zoning Map of the City of Royal Oak is hereby adopted on second reading.

The City of Royal Oak ordains:

Section 1 Ordinance. Pursuant to the provisions of the Michigan Zoning Enabling Act, Public Act 110 of 2006, as amended, and pursuant to all applicable provisions of law, the Zoning Map of the City of Royal Oak is hereby amended to rezone 723 North Main Street (parcel no. 25-16-430-012) from "Neighborhood Business" to "Planned Unit Development," and the final planned unit development site plan (SP 24-11-13) to construct a multiple-family building with four stories and 24 dwellings at 723 North Main Street (parcel no. 25-16-430-012), is hereby approved, subject to the associated "development agreement."

<u>Section 2 – Severability.</u> If any section, subsection, clause, phrase or portion of this ordinance is for any reason held invalid or portion of this ordinance is for any reason held invalid or unconstitutional by any court of competent jurisdiction, such portion shall be deemed a separate, distinct and independent portion of this ordinance, and such holding shall not affect the validity of the remaining portions of this ordinance.

<u>Section 3 – Savings.</u> As proceedings pending and all rights and liabilities existing, acquired or incurred at the time this ordinance takes effect are saved and may be consummated according to the law in force when they are commenced.

<u>Section 4 – Repealer.</u> All ordinance or parts of ordinances in conflict herewith are hereby repealed only to the extent necessary to give this ordinance full force and effect.

<u>Section 5 – Effective Date.</u> This ordinance shall be published in a newspaper of general circulation in the City of Royal Oak and shall become effective ten (10) days after publication, as provided by law.

Be it further resolved that the associated development agreement required under Article VIII of the Zoning Ordinance is hereby approved, pending any final revisions from the City Attorney, and that the Mayor and City Clerk are hereby authorized to execute the development agreement.
