EXECUTIVE SUMMARY (include history of previous Commission action/discussion, background, scope of work, etc.):

The 2025 Winter Blast Festival will take place from Friday, January 31 through Sunday, February 2, 2025, in and around Centennial Commons and the Royal Oak Civic Center campus. Most festival goers will be using either the 11 Mile or Center Street parking garages or the Civic Center campus surface lots to attend the festival. Based on last year's attendance and anticipated festival goers, staff is recommending a flat parking fee of \$5.00 to be charged at the entrance of these respective parking garages and lots.

Park Rite will have attendants at the entrance of the parking areas to accept payment at each structure or lot. This is a similar payment collection method used for prior Winter Blast festivals, which resulted in a better experience for attendees who were able to exit easier and quicker when leaving, especially during peak hours.

As a temporary rate structure for special events, the city's ordinance governing parking provides that parking fees may be fixed by Resolution of the City Commission.

Should the City Commission desire to approve the proposed \$5.00 parking fee for the event, a proposed Resolution is provided for your consideration. Should the City Commission desire to amend the proposed parking fee for this event similar to parking fee adjustments recently made for the Arts, Beats & Eats and Taco Fest events, this item would need to be removed from the consent agenda and an appropriate revision to the proposed Resolution be made.
