## EXECUTIVE SUMMARY (include history of previous Commission action/discussion,

background, scope of work, etc.):

In December of 2023, Governor Whitmer signed Senate Bills 572 and 573 to allow the expansion of precinct sizes from 2,999 voters to 4,999 voters. When this happened, I brought forward a recommendation to the city commission to approve a reduction of the city's precincts from 24 to 18. Since that time, we have had three elections held including the presidential election last November. There have been no issues with decreasing the number of precincts.

After doing a second evaluation of the number of precincts, I have realized that we can consolidate even more precincts bringing the total number down from 18 to 15. The three changes would include having one precinct at the Salter Community Center (instead of 2), one precinct at Jane Addams (instead of 2) and one precinct at Northwood (instead of 2). Every ten years we purchase new voting equipment. The state is going out for RFP's soon for new election equipment vendors in 2026 for the changeover in 2027. The Bureau of Elections is recommending that we budget \$15,000 per precinct for the new equipment. Eliminating the proposed three precincts will save the city \$45,000 for new equipment.

It is a good time to make these additional consolidation changes as our State Senate district has just changed from district 8 to district 10. With this change, all voters in the city of royal oak must receive a new voter id card showing the new district change. In doing this they will be made aware of their new precinct number and their new senate district number. This recommendation was also brought forward to the Election Commission and unanimously approved on June 16, 2025.
